
Directions to Pierce County's Frontier Park:

From Hwy 512 Eastbound

- Take the Summit/Canyon Rd E exit (third exit, approx. 5.8 miles). Turn right.
- Go south on Canyon Rd to 176th St E. (4.5 miles). Turn right.
- Go east on 176th St E to Hwy 161/Meridian East (3 miles). Turn sharp right.
- Go south on Meridian (2.7 miles).
- Turn right on 218th Street (traffic light) into park entrance

From Hwy 512 Westbound

- Take the Summit/Canyon Rd E exit (first exit after South Hill Mall, 2.5 miles). Turn left.
- Go south on Canyon Rd to 176th St E (4.5 miles). Turn right.
- Go east on 176th St E to Hwy 161/Meridian East (3 miles). Turn sharp right.
- Go south on Meridian (2.7 miles).
- Turn right on 218th Street (traffic light) into park entrance
